3. Self attested photocopies of proof of Date of Birth – copy of Class X admit card / certificates containing the Date of Birth.
4. Self attested photocopies of proof of SC/ST/OBC-A/OBC-B/PWD/EWS candidate (if applicable).
5. Self attested photocopy of Aadhaar card.
6. Self attested photocopy of APPAR ID / ABC ID.
7. Domicile Certificate for reserve category candidate (if applicable).
8. Self attested photocopies of Hall Ticket, verified at the Exam Centre.

- The choices / preferences submitted by the candidates will be processed and seat will be provisionally allotted in the order of merit as per application form submitted.
