An Entrance Test **CULET-UG** (Calcutta **U**niversity **L**aw **E**ntrance **T**est Under Graduate) to be conducted in **CBT** (Computer Based Test) mode.

Merit list will be prepared on the basis of marks obtained in the Entrance Test.

Selection will be made strictly on the basis of merit and availability of vacant seat through **e-counseling**.

Particulars in respect of application and other information are given below:

A. Eligibility:

1. Passed 10+2 or its equivalent examination from the Board recognized by the University of Calcutta and there is **no age bar**.
2. **Marks** obtained in the 10+2 level examination from the Board recognized by the University of Calcutta.
 - a. **GENERAL (UNRESERVED): At least 45% marks in best of four subjects.** (Excluding compulsory Environmental Studies).
 - b. **SC/ST/ PWD (PERSON WITH DISABILITY) (Disability 40% or more): At least 40% marks to be obtained by the candidate in best of four subjects.** (Excluding compulsory Environmental Studies).
 - c. **OBC/EWS: At least 42% marks to be obtained by the candidate in best of four subjects.** (Excluding compulsory Environmental Studies).
3. Candidate who has passed 10+2 from the Board **other than WBCHSE, ISC, CBSE, Rabindra Mukto Vidyalyay and NIOS must be obtained "EQUIVALANCE CERTIFICATE"** from the office of the Registrar, (Equivalence Section) University of Calcutta, 87/1, College Street, Kolkata-700073 by a written application in plain paper with relevant photo copy of 10+2 Mark Sheet. Certificate will be required at the time of Admission. It will be safe to obtain the certificate before online application submission.
4. **Foreign Student:** Foreign National with last qualifying eligibility degree from Foreign Board has to apply in writing to the undersigned mentioning all previous degrees, mark sheets, certificates and syllabus of the last qualifying examination eligibility degree, High Commission Forwarding and AIU/UGC Equivalence Certificate. After preliminary verification they may be called for interview. If qualified in interview the C.U. equivalence certificate has to be collected. After getting equivalency clearance a provisional list will be prepared for approval of Vice-Chancellor, C.U. Lastly selected candidates will get admission with all required documents.

Foreign National with last qualifying eligibility degree from Indian universities/boards candidates may also apply like other Indian national candidates.
5. **Reservation:** As per the Govt. of West Bengal Rule: For SC 22%; ST 6%; OBC 7%; EWS 10% additional. For PWD 5% Horizontal Reservation.

B. Application Fees

Rs. 1000/- for General Category, OBC, EWS and

Rs. 500/- for SC/ST/PWD to be paid online through admission portal.

C. Submission of Application:

- (i) Submission of Application and Application Fee will be paid through Online Mode
(See the Admission Schedule for details)

(ii) Candidate has to submit online application with all the colleges/institutes preferences or its part with order of preferences (with Hons. / Without Hons.) during the application process.

(iii) Significance of Order of Preference

- a) A candidate may apply for more than one institute with Order of Preference. Candidate should give order of preference carefully; it may not be changed later. Higher preference will be open for up gradation in next phases of e-counseling and lower preferences will be closed.
- b) The preference '1' is high option than preference '2' and so on. The candidate should select the Institute as preference '1' which he/she thinks the best one and he/she intends to get admission, if he/she gets chance. Accordingly, 2nd best Institute as preference '2' and so on.
- c) During Selection process, all the options of the candidate with Higher Merit will be considered first then the options of the next higher merit candidate will be considered. Once the candidate is selected in one option, all the lower options will be closed, keeping the higher options, if available, remains open for future chance.

F. **IMPORTANT INSTRUCTIONS FOR CANDIDATES:** **FOR CULET-UG 2026 IN CBT (Computer Based Test) MODE**

For Date, Time of Exam, Venue and Reporting Time: Please check Entrance Test Schedule available on the website as well as in Hall Ticket.

1. Under no circumstances, entry to exam hall will be allowed without this Hall Ticket. Candidates should check the Hall Ticket carefully and bring discrepancies, if any, to the notice of the University's office immediately.
2. If the photograph or signature on the Hall Ticket is defective or illegible or missing, candidates are requested to draw the notice of the authority & to bring 2 (two) stamp size photographs along with any one of the following documents: (i) Madhyamik or equivalent certificate bearing photograph, (ii) PASSPORT, (iii) PAN Card, (iv) AADHAAR Card, (v) EPIC (Voter Identity Card) and (vi) Driving License.
3. Candidate should report at their respective test center 90 minutes before exam start time. **Entry to the test center will be closed 30 minutes prior to the commencement of the exam.**
4. Entry to the Examination Hall will be closed 30 minutes prior to the commencement of exam.
5. **ADMISSION TO THE EXAMINATION IS PURELY PROVISIONAL SUBJECT TO DETERMINATION OF ELIGIBILITY IN TERMS OF THE ADVERTISEMENT.**
6. The Examination will be CBT (Computer Based Test) mode.
7. Paper required for rough work will be provided at the Examination Hall. On Screen Scientific Calculator will be available on computer screen at the time of Examination.
8. Full Marks: 100, Time: 2:00 Hour.
9. **Only Hall ticket, photo ID card and pen will be allowed inside the Test Hall.**
10. **Mobile phones, cap/hat, electronic gadgets, watches, calculators, stationery items, papers, wallets, goggles, jackets and any jewellery or items containing metal will NOT BE ALLOWED inside the Test Hall.**
11. There is no facility for **safekeeping** of your personal belongings outside the test hall and nobody will be responsible for any kind of loss.
12. ***Specially eligible PWD candidates may avail extra time of 20 minutes per hour for the test subject to prior approval from appropriate authority of the University. Those PWD candidates who require any special assistance due to medical reason must seek prior approval letter from Calcutta University by 7 days prior to the date of entrance test. Please write to (helpdesk email ID) along with applicable medical certificate to request for approval. The decision from Calcutta University in this regard stands final.***
13. You will be awarded **(+1 marks)** for each correct answer, **(-0.25 Marks)** for each wrong answer and **Zero** for no try.
14. Normal instruction of Examination and practices of Demo Mock Link will be available in the University Website in due time.
15. No candidate will be allowed to leave the examination hall before completion of the examination.

16. Hall Ticket issued on the basis of data provided by the candidate, without any verification. Mere appearance in Entrance Tests not be claimed as eligible for admission, application will be treated as cancelled if found ineligible even after Entrance Tests and after admission also.

17. NO CHANGE OF TEST CENTRE WILL BE ENTERTAINED.

G. CRITERIA FOR PREPARATION OF MERIT LIST:

Merit List shall be prepared **strictly on the basis of marks obtained in the Entrance Test**, arranged in **descending order of merit** (i.e., from highest to lowest score).

In the event of **two or more candidates securing identical marks** in the Entrance Test, the following **tie-breaking criteria** shall be applied **sequentially** until the tie is resolved:

First Tie-Breaking Criteria:

Candidates with lower no. of wrong answer will be placed higher in rank.

Second Tie-Breaking Criteria:

The **percentage of marks obtained in the best four subjects (excluding Environmental Studies/Environmental Science – ENVS) at the (10+2) level** (or equivalent examination) shall be considered.

Candidates with a higher aggregate percentage in these best four subjects will be placed higher in rank.

Third Tie-Breaking Criterion:

If the tie persists, the percentage of marks obtained in English or English Core at the (10+2) level shall be taken into account.

The candidate securing a higher percentage in English or English Core will be ranked higher.

H. Selection Process: (Methodology of e-Counseling):

- (i) Selection is done strictly on the basis of merit and following selection rules and availability of vacant seat(s).
- (ii) During Selection process, all the options of the candidate with Higher Merit will be considered first then the options of the next higher merit candidate will be considered. Once the candidate is selected in one option, all the lower options will be closed, keeping the higher options, if available, remains open for future chance.

I. Publication of Selection Lists:

- (i) Separate selection lists for different categories (UR/SC/ST/OBC/EWS/PWD/WOP(only for KPLI)) and with Hons. & without Hons. to be published on the University Admission portal.
- (ii) In case of self-sponsored Institute / College, only **UR & EWS** Selection Lists will be published 2nd Selection List onwards for all category vacant seats.

J. Documents Upload:

- (i) After the selection list is published, selected candidates must log-in to the admission portal using their user ID and password.
- (ii) They must upload all necessary documents in a single PDF file (maximum 2 MB) if he/she interested to get admission.

K. Documents Verification:

- (i) Verification is performed by both the University of Calcutta and the respective college authorities.
- (ii) Only after the college authorities are satisfied with the candidate's eligibility the candidate can proceed to pay the Residual admission fee (Admission Fee minus Seat Booking Fee).
- (iii) **Eligibility Verification and Consequences for Misrepresentation:**
 - a) Candidates are responsible for verifying their own eligibility as per the 2026 admission notice.
 - b) Provisional admission does not guarantee final admission if eligibility requirements are not met.
 - c) If forged or fake documents are discovered at any point, the candidate's admission will be immediately canceled without notice. The candidate will also be prosecuted and permanently debarred from any future University of Calcutta admissions or entrance tests.
 - d) Overlooking a candidate's ineligibility is not a right that can be claimed later.
 - e) Mere submission of Application form, appearance in Entrance Test does not entitle a candidate to be considered for admission to the course unless he/she fulfils the eligibility conditions.
 - f) Physical verification of all documents in original will be done after admission as per schedule to be notified in due course.

L. Seat Booking Fee:

The candidate in selection list if interested to get admission have to pay seat booking fee at the rate:

- a) Rs. 2,000 for C.U. departments, government-sponsored, or government-aided Institutes.
- b) Rs. 10,000 for self-financed colleges.
- c) **Fee Payment and Refund / Adjustment for Transfer from one Institute to other:**
 - i. **Residual Fees:** The remaining admission fees (Total Admission Fees - Seat Booking Fees) must be paid to the respective college.
 - ii. **Timing of Payment:** The residual admission fees to be paid during the counseling period. **Semester fee** to be paid **after e-counseling is completed** (actual date to be notified by the CU Admission office).
 - iii. **Transfer / Refund:** If a candidate changes colleges during the counseling process, they can claim a refund of the residual admission fees. (Actual date to be notified by the CU Admission office).
 - iv. **Transfer from government aided Institute to self-financed Institute:** If a candidate paid Rs. 10,000 for a seat in a self-financed college and in later stage, if the candidate selected for a government aided college (where the seat fee is Rs. 2,000), they will pay only the residual fee at the new college. The Rs. 8,000 differences will be refunded to the

candidate by the university upon submission of a claim (actual time/date for submission of a claim to be notified by the CU Admission office).

- v. Refund of fees in case of cancellation of admission / cancellation due to transfer from one institute to another will be done following Refund Policy of C.U.

M. Mop-up rounds for next selection lists:

(i) Mop-Up Round Registration:

- a) A "MOP-UP" round is conducted after the first selection list to fill the remaining seats.
- b) Candidate wishing to get a chance in the next selection list, he/she must register ONLINE by login into the admission portal by using his/her USER ID (Application No.) and Password. **No fee is required for registration.**
- c) Candidates who are **already admitted** to any college, as well as candidates **not admitted anywhere**, may participate for the counseling. **Candidate those who already got the 1st preference will not be considered to participate in MOP-UP round for next selection list.**
- d) **Candidate** already selected in any college/institute **will not be allowed to give preference(s) of the Institute(s) where he/she already selected in previous selection list(s).**
- e) **If a candidate is selected for admission in any college through MOP-UP round counseling and does not take admission, his/her candidature will be treated as cancelled, and he/she will not be allowed to participate in any further counseling.**
To avoid these circumstances, candidates should not opt for college(s) in during MOP-UP registration where they do not wish to take admission.
- f) The Candidates who do not register for a MOP-UP round his/her name will not be in next selection list. However, he/she may participate in next MOP-UP round.
- g) For each MOP-UP round candidate have to register separately following same process.

(ii) Next Selection Lists and admission:

- (a) Next selection lists will be published based on the merit of the registered applicants of respective MOP-UP round.
- (b) Candidates selected in subsequent lists follow the same procedure as the first selection list (document upload, seat booking fee, and residual fee payment).

N. Criteria for Selection of Reserved category candidate:

(i) SC/ST/PWD:

Where merit list is prepared on the basis of marks obtained in the entrance test only, the SC/ST/PWD candidate should obtain marks in the entrance test not lower than 25% than that of obtained by the last candidates selected of UR Category in a specific institute.

(ii) OBC/EWS:

Where merit list is prepared on the basis of marks obtained in the entrance test only, the OBC/EWS candidate should obtain marks in the entrance test not lower than 10% than that of obtained by the last candidates selected of Unreserved Category in a specific institute.

(iii) "Unreserved Category" consideration of Reserved category candidate:

SC/ST/PWD/OBC/EWS candidates those who have entrance test marks equal to or higher than the last selected UR candidate will also be considered under the Unreserved Category.

(iv) Reservation for OBC:

As per Govt. of WB order 7% Seats are reserved for 66 community of the OBC category (non-Creamy layer).

(v) Reservation for Wards Of Police (WOP) in Kolkata Police Law Institution:

80% of seats at the Kolkata Police Law Institution (LWKPL) are reserved for WOP candidates. In support of WOP, candidate must submit authenticate document.

O. Admission Schedule:

Date, Time, Venue etc. will be available on Admission Schedule which will be updated time to time. Candidate is required to check the admission schedule and others notifications time to time on admission portal/Website. Individual communication may not be possible.
