Fee Payment and Refund / Adjustment for Transfer from one Institute to other:

The candidate in selection list if interested to get admission have to pay:

- i. **Seat Booking Fee Structure:**
 - a) **Rs. 2,000** for C.U. departments, government-sponsored, or government-aided Institutes.
 - b) **Rs. 10,000** for self-financed colleges.
- ii. **Residual Fees:** The residual admission fees (Total Admission Fees minus Seat Booking Fees) must be paid to the respective college. For payment of Semester Fee separate notice will be published immediately after completion of e-counseling.
- iii. **Timing of Payment:** The admission fees to be paid during the counseling period. Semester fee to be paid after e-counseling is completed.
- iv. **Admission Process in respect of payment of a candidate will not be completed till deposition of 1st Semester Fees in respective Institutes / Colleges.**
- v. **Refund due to Transfer:** If a candidate changes colleges during the counseling process, they can claim a refund of the residual admission fees.
- vi. **Transfer from government/aided Institute to self-financed Institute:** If a candidate paid Rs. 10,000 for a seat in a self-financed college and is later selected for a government/aided college (where the seat fee is Rs. 2,000), they will pay only the residual fee at the new college. The Rs. 8,000 difference will be refunded to the candidate by the university upon submission of a claim.
- vii. **Refund of fees in case of cancellation of admission / cancellation due to transfer from one institute to another will be done following Refund Policy of C.U.**
