GENERAL INFORMATION

1. The candidates are required to apply through ONLINE process only accessing the website www.caluniv.ac.in & www.caluniv-ucsta.net. **Candidates are advised to read the instructions carefully before starting the process of online application.**
2. Candidates applying for more than one discipline have to select all the courses at a time during online submission of application(s). System will automatically generate the no. of application form(s) candidate have applied. **Candidates must keep a hardcopy (print out) of the submitted application form** and other relevant document signed by the candidate in each pages of documents & form. All these document to be submitted for verification when called for in notice.

Part-'A' Candidates (current year and immediate preceding C.U. Graduate students including Autonomous Colleges of this University)

C.U. candidates means candidate who passed the required Bachelor Examination as eligibility degree for admission in relevant P.G. courses, from Calcutta University.

Part-B Candidates (current year and immediate preceding year Non C.U. graduates)

Non-C.U. candidates means candidate who passed the required Bachelor Examination as eligibility degree for admission in relevant P.G. courses, from the University other than Calcutta University.

3. Incomplete application / application without relevant supporting documents shall be out rightly rejected and no correspondence in this regard shall be made. No correspondence will be entertained from the candidates in connection with the process of short listing / selection.
4. The University reserves the right to withdraw the admission at any stage in case a candidate does not possess the requisite qualification and / or percentage of marks in qualifying degree or supplies any false information.
5. In case of any mistake occurs inadvertently in the process of selection, which may be detected at any stage of admission, the University reserves the right withdraw / cancel / modify any communication made to the candidates.
6. Please note that all information related to admission will be available in the University website www.caluniv.ac.in and www.caluniv-ucsta.net.

NOTE : i) Mere fulfillment of eligibility criteria does not guarantee admission in a programme. Applicants must satisfy themselves about their eligibilities as prescribed before filling in the application form.
